#### **Background:**

The Queens Library Foundation (Foundation) operating costs are generally paid from the Foundation's General Fund Budget. The Library employs and pays for the Personal Service costs of the development staff. These costs are recorded as contributed services to the Queens Library Foundation from the Queens Library.

The Foundation's FY'19 General Fund Budget reflects the contributed personal services, operating expenses and corresponding contributed revenue provided by the Library without a net budget effect.

The operating budget, approved by the Foundation Board of Directors, must also be approved by the Library Board of Trustees, in accordance with the Foundation's Corporate By-Laws.

#### **Current Status:**

The FY'19 budget reflects a reorganization of funding and corresponding expenses in order to align the grant process with Library programs. All individual contributions, corporate and foundation grants, planned gifts, endowments and revenue generated by fund raising events will be recorded by the Foundation. Government grants will be recorded by the Library as in the past.

The Personal Services budget line has increased by five positions as a result of the reorganization. The Foundation will continue to record the cost of the budgeted staff as contributed services from the Library.

The attached Queens Library Foundation Fiscal Year 2019 General Fund Budget document dated June 5, 2018 was reviewed and approved by the Queens Library Foundation Board of Directors at their meeting on June 5, 2018.

The attached document provides a detailed review of the proposed FY'19 QLF General Fund Budget. Estimated revenues total \$2,299,108. Proposed appropriations equal \$2,299,108.

### **Recommended Motion for Consideration by the Board of Trustees:**

I move that the Board of Trustees accept the adoption of the Queens Library Foundation FY'19 General Fund Budget as detailed in the Fiscal Year 2019 General Fund Budget document dated June 5, 2018.
