V. President's Report

Dennis M. Walcott, President and CEO, asked that Nick Buron, Chief Librarian and Sr. VP give the board on the status of the Library. Mr. Buron reported that the Hip Hop Team has brought a new exhibit to the Central location. This exhibit, created by Sherwin Banfield and titled "A Cypher in Queens," consists of three statutes of three Queens hip hop artists: Jam Master Jay of RUN DMC, Phife Dawg of A Tribe Called Quest, and Prodigy of MOBB DEEP. The exhibit will be at Central Library from September 2019 to February 2020. The opening night event was September 19th . The statues are located outside the Media Center door on the first floor.

The exhibit includes audio. Fifty headphones are available in the Central Library Media Center. There will also be health related programming associated with this exhibit on sickle cell anemia and diabetes, as that is how two of three artists died.

Mr. Buron also reported that the Queens Public Library Foundation has secured a nearly \$1 million grant through the City Parks Foundation -- \$995,993 over the next three years -- to operate an environmental education center at Hunters Point Library.

He also reported that the Hunters Point Environmental Education Center was modeled after the Children's Library Discovery Center at Central. The Hunters Point Environmental Education Center will offer a new STEM learning dimension to the branch, giving children ages 3 to 12 the opportunity to understand, study and learn about plant and marine life, pollution, composting, recycling and many other subjects. The center will open this fall.

Gitte Peng, Chief of Staff and Sr. VP and Mr. Buron spoke about the importance of libraries in ensuring a complete count for the 2020 Census. Ms. Peng said that the City was giving \$1.4 million to the three library systems to develop and implement efforts in every community to maximize participation, which affects the allocation of billions of dollars of federal funding as well as political representation. Mr. Buron pointed out that the majority of respondents would complete this upcoming Census online, and libraries will play a key role in providing Internet and technology access, as well as performing outreach so that people participate. The Library will be countering misinformation and fear about participating. Ms. Peng added that census forms would be available in only 12 languages in addition to English. The outreach and other work of our staff will be critical

in reaching hard-to-count populations. Our staff have already started to receive training. The City is planning an ongoing campaign-style effort, and the Library will be working closely with the City, community-based and other organizations, and the other two library systems in this work.

Mr. Walcott reported that Mr. Finkelman would be retiring on Friday, September 27. Mr. Walcott personally thanked Mr. Finkelman for his time, service, and support to Queens Library. He asked Mr. Finkelman if he would like to say a few words and give a final report to the board.

Mr. Finkelman stated that working at Queens Library has been a privilege and honor. He appreciated the trust and support he received from the board and staff.

Mr. Finkelman gave his final report to the board. He reported that prior to his being hired, the Library had begun the process of transferring ownership of the Mitchell-Linden property to the City. Mr. Finkelman was asked to complete this transfer because he was familiar with the City's Uniform Land Use Review Procedure (ULURP). He indicated that he was pleased to announce that the sale of the Mitchell-Linden condominium units had been completed and that the Library had received approximately \$4.3 million from the sale.

He wished the Library all the best.
