IN FY 19, QUEENS LIBRARY OFFERED FREE ACCESS TO A COLLECTION OF MORE THAN 5 MILLION BOOKS AND OTHER MATERIALS IN MULTIPLE LANGUAGES, WHICH CIRCULATED OVER 11.5 MILLION TIMES. THE LIBRARY HAD OVER 10.8 MILLION VISITS AT ITS 65 LOCATIONS ACROSS THE BOROUGH. MORE THAN THREE MILLION PEOPLE USED THE LIBRARY'S COMPUTERS OR ACCESSED THE WI-FI NETWORK. THE LIBRARY OFFERED OVER 89,000 EDUCATIONAL, CULTURAL, AND CIVIC PROGRAMS WITH AN ATTENDANCE OF MORE THAN 1.6 MILLION CUSTOMERS.
