Background:

The Library's By-Laws provide, in pertinent part, that they may be amended at any meeting of the Board of Trustees, subject to the requirement that any proposed amendment shall be read at a meeting and voted upon at a subsequent meeting.

Current Status:

The Board of Trustees, at its regularly scheduled meeting held on February 27, 2020, approved amending the By-Laws to delete the following phrase in Article V, Section 7: "...in November of each year...", and to adopt substitute language in Article V, Section 7 "...no later than November of each year..." as referenced in the attachment hereto. As discussed at the February 27 meeting, the purpose of this amendment is to permit flexibility in timing for the election of the Nominating Committee, and to avoid the need for three consecutive meetings in November, December, and January. The By-Laws require that these amendments also be voted upon at a subsequent meeting in order to be effective.

Recommended Motion for Consideration by the Board of Trustees:

I move that the Board of Trustees approved amending the By-Laws to delete the following phrase in Article V, Section 7: "...in November of each year...", and to adopt substitute language in Article V, Section 7 "...no later than November of each year..." as referenced in the attachment hereto.

Section 6. <u>Buildings and Grounds Committee</u>. The Buildings and Grounds Committee shall recommend policies for the care and maintenance of the Library buildings and grounds and approve such sites for additional Library buildings as may be deemed necessary for the use of the Corporation when presented with the long-term capital plan, in coordination with the Vice President, Capital and Facilities Management. The Buildings and Grounds Committee shall also oversee the construction activities of the Corporation.

Section 7. <u>Nominating Committee</u>. A Nominating Committee shall be elected <u>in no later</u> <u>than</u> November of each year and shall prepare and submit to the Board of Trustees at least ten days prior to the Board's regular meeting in December the slate of candidates for the officers of the Corporation. Any Trustee may offer additional nominees for any office at the Board's regular meeting in December. The Nominating Committee shall consist of five members, two of whom shall be appointed by the Chairperson of the Board and three of whom shall be elected by the Board.

Section 8. <u>Meetings</u>, Notices and Records. Each committee of the Board may provide for the holding of regular meetings, with notice, and may fix the time and place at which such meetings shall be held. Special meetings of each committee shall be held upon call by or at the direction of the committee's chairperson or, if there be no chairperson, by or at the direction of any of its members, at the time and place specified in the respective notices or waivers of notice thereof. Notice of each special meeting of a committee shall be given by first-class mail, telecopy, electronic mail or hand delivery to each member of such committee and all other trustees, at least forty-eight hours before the meeting. Notice of any meeting of a committee need not be given to any member thereof who shall attend the meeting in person without objection or who shall waive notice thereof. Notice of all meetings of committees and subcommittees of the Board shall be given to the public in accordance with the Open Meetings Law, provided that, notwithstanding anything to the contrary in the Open Meetings Law, public notice of the time and place of a meeting of a Board committee or subcommittee scheduled at least two weeks prior thereto shall be given to the public and news media at least one week before such meeting.
